



# Everything You Should Know About Registration of Legal Entities in Tajikistan

Tajikistan, located in Central Asia, offers ample business opportunities to businesses. Entrepreneurs those looking to establish their business organization, need to understand the legal entities registration process. Here is all about the registration of legal entities in Tajikistan and how this job can be done easily.

## Authorities and Legal Framework Tajikistan



The registration of any kind of legal entities in Tajikistan is mainly conducted by the Civil Code of Republic of Tajikistan. This is the law on State Registration of Legal Entities and Individual Entrepreneurs along with other legislative acts. The registration process mainly managed by the Tax Committee of the Republic of Tajikistan that ensures the businesses properly adhere to the local laws and regulations.

Tajik government mainly encourage foreign investors and they have to also go through the same procedure as the entrepreneurs though, there are some additional documentation may be required solely depending on the nature of the business.

## Steps Involved in Registering Entities

**Reservation of Name:** Before starting the registration process, the business leaders have to check the availability of their intended business name. If they confirm that, the name is available, then they should reserve it immediately. This process is done through the tax committee and it ensures that the chosen name is unique and does not conflict with any kind of entities that already exist there.

## Preparing Documentation



The registration process is done by preparing a accurate documents. These are including:

- A properly filled application form
- The charter of the company
- Identification documents of the founders and directors of the entity
- Proof of the legal address
- Bank statement that bears the registration fee of the company

## Application Submission

Once the documents are gathered, the application form must be submitted at the tax committee. It can also be done though the official portal at the tax office.

**Getting Registration Certificate:** If all the documents are on order, the tax committee has to issue a registration certificate in five to seven business days. This certificate mainly confirms that the legal entity is officially recognized and allowed to operate in the Tajikistan.

**Registration for Tax and Statistics:** The business entity have to register with the tax authorities and statistical agency in addition to the registration certificate upon receipt. with doing this, the business may be certain that it abides with tax laws and is reported in national statistics.

**Opening a Bank Account:** The business organization has to create a corporate account with a Tajikistani local or foreign bank. All payments for taxes and other financial transactions will be made using this account.

By registering under the Tajikistan corporate law would let you operate your business. Though, the [registration of legal entities in Tajikistan](#) may take few weeks, it will let you operate the business properly without any additional hesitation while tapping the developing economy of Tajikistan.

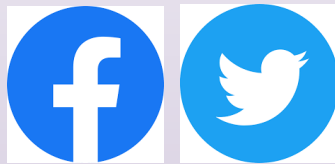
